

Only 9 Percent Reinvestment from BC Partners' Recent Investors

In the ten years that passed between the closing of BC Partners' ninth and eleventh flagship funds in February 2012 and 2022 respectively, only 9 percent of the initial investors decided to reinvest. The fund placement agents, Sixpoint Partners, report that a <u>healthy reinvestment rate is 70 percent</u>, suggesting a good reinvestment rate for BC Partners across two funds would be around 50 percent. This loss of confidence is also reflected in BC Partners' inability to hit their fundraising goal for their eleventh fund while their peers shot past their goals by <u>23 percent on average</u>. While none of the largest 15 funds that closed in 2021 failed to reach their targets, BC Partners would have been an outlier in that group if they hadn't pushed back their initial 2021 close date. Even with the extra two quarters, they still only hit 62 to 81 percent of their <u>8.5 billion euro goal for August 2021</u>.¹

Some of the largest funds to not reinvest in the eleventh fund are: the Alaska Retirement Management Board, the Florida State Board of Administration, the Iowa Public Employees' Retirement System, the Los Angeles City Employees' Retirement System, the Michigan Department of Treasury, the Pennsylvania State Employees' Retirement System, the Public Employees' Retirement System of Nevada, the Teachers' Retirement System of Louisiana, and the Washington State Investment Board.

This research brief includes three tables based on the filings on the <u>UK Government's Companies</u> <u>House registry</u>.² Unlike many private equity firms, BC Partners is required to file LP6 forms to name each Limited Partner with the UK Government, so it is possible to get a precise accounting of their Limited Partners. Table 1 lists the investors in the 9th fund that did not reinvest in the 11th. Table 2 lists all of the investors in the 9th fund, and table 3 lists all of the investors in the 11th fund. In the tables, the "Company Name" is the registered name of the derivative fund with the UK government, and the "date" is the date listed on the "filing history" tab. The ninth fund closed on 2/21/2012 and all investors are included through 5/31/2012. The eleventh fund closed on 2/7/2022 and all investors are included through 5/31/2022.

Each table only includes unique investors. There were 180 unique investors in the 9th fund, and only 79 unique investors in the 11th. The following rules were applied to count unique investors:

- Multiple funds from the same entity were counted as a single investor
- Companies with pension funds for multiple countries were counted as a single investor
- Advisors acting on behalf of investors were counted as separate investors
- Family members were counted as a single investor
- The New York City Retirement System was counted as a single investor

¹ The percentage range reflects the uncertainty in how much BC Partners raised for their 11th fund. In a story that BC Partners declined to comment in, <u>Bloomberg reported</u> they raised 5.3 billion euros. In contrast, BC Partners <u>press release</u> says they raised 6.9 billion euros "across all related vehicles."

² The search terms used were BC Partners IX for the ninth fund and BC Partners XI for the eleventh fund.
